CONSENT FOR ESTABLISHMENT ORDER

Sub: APPCB – CFE - **M/s. Coromandel International Ltd., Beach Road, Vakalapudi, Kakinada Rural, East Godavari District** – Consent for Establishment of the Board for **expansion of Sulphuric Acid storage tanks** under Sec.25 of Water (P & C of P) Act, 1974 and Under Sec.21 of Air (P&C of P) Act, 1981 - Issued - Reg.

1. In the reference 2nd cited, an application was submitted to the Board seeking Consent for Establishment (CFE) for establishment of 2 x 10000 MTs capacity storage tanks by replacing existing 2x2400 MTs storage tanks for storage of Sulphuric Acid as following with an additional investment of 20.0 Crores.

2. As per the application, the above activity is to be located within the existing plant premises located at Beach Road, Vakalapudi, Kakinada Rural, East Godavari District.
3. The above industry was inspected by the Environmental Engineer, Asst. Environmental Engineer & Analyst Grade - I, Regional office, Kakinada, A.P Pollution Control Board on 16.02.2019.
4. The Board, after careful scrutiny of the application and verification report of Regional Officer, hereby issues **CONSENT FOR ESTABLISHMENT FOR EXPANSION OF SULPHURIC ACID STORAGE CAPACITY** under Section 25 of Water (Prevention & Control of Pollution) Act 1974 and Section 21 of Air (Prevention & Control of Pollution) Act, 1981 and the rules made there under. **This order is issued to the activity as mentioned at para (1) only.**

5. This Consent Order now issued is subject to the conditions mentioned in the Annexure.
6. This order is issued from pollution control point of view only. Zoning and other regulations are not considered.
7. **This order is valid for period of 7 years from the date of issue.**

ANNEXURE

1. The proponent shall obtain Consents for Operation (CFO) from APPCB, as required Under Sec.25/26 of the Water (P&C of P) Act, 1974 and under sec. 21/22 of the Air (P&C of P) Act, 1981, before commencement of the activity.
2. Compensation is to be paid for any environmental damage caused by it, as fixed by the Collector and District Magistrate as civil liability.
3. The rules and regulations notified by Ministry of Law and Justice, GOI, regarding the Public Liability Insurance Act, 1991 shall be followed.
4. There shall not be any water consumption and waste water generation in the proposed activity.
5. The industry shall provide dyke wall around the proposed storage tanks with collection pit.
6. The proponent shall take necessary measures like providing dust suppression system to control dust emissions generated during construction phase due to excavation and movement of the vehicles.
7. There shall not be any generation of solid waste from the proposed activity.
8. The industry shall take all the safety precautionary measures as per Onsite Emergency Plan submitted by the industry including mitigation measures.
9. **The proponent shall ensure compliance of the National Ambient Air quality standards notified by MOE&F,GoI vide notification No. GSR 826(E), dated. 16.11.2009 during construction and regular operational phase of the project.**
10. The proponent shall comply with all the directions issued by the Board from time to time.
11. Concealing the factual data or submission of false information / fabricated data and failure to comply with any of the conditions mentioned in this order attracts action under the provisions of relevant pollution control Acts.
12. Notwithstanding anything contained in this conditional letter or consent, the Board hereby reserves its right and power Under Sec. 27(2) of Water (Prevention and Control of Pollution) Act, 1974 and Under Sec.21(4) of Air (Prevention and Control of Pollution) Act, 1981 to revoke the order, to review any or all the conditions imposed herein and to make such modifications as deemed fit and stipulate any additional conditions.

13. Any person aggrieved by an order made by the State Board under Section 25, Section 26, Section 27 of Water Act, 1974 or Section 21 of Air Act, 1981 may within thirty days from the date on which the order is communicated to him, prefer an appeal as per Andhra Pradesh Water Rules, 1976 and Air Rules, 1982, to such authority (hereinafter referred to as the Appellate Authority) constituted under Section 28 of Water (Prevention and Control of Pollution) Act, 1974 and Section 31 of the Air (Prevention and Control of Pollution) Act, 1981.
